On Tuesday, January 12, 2016 the Northeastern System Federation held a Nomination Meeting at the Quality Inn in Oneonta, NY at 7 PM to for the purposes of nomination of Delegate and Alternate Delegate for the IBT International Convention that was to be held in Las Vegas, Nevada between June 21-25, 2021 which has since been changed to be handled remotely as of January 6, 2021.

There was one (1) written nomination, second and acceptance for the NESF Delegate and one (1) written nomination, second and acceptance for the Alternate Delegate. There were no nominations made, seconded or accepted at the meeting. Therefore, as a result your Delegate and Alternate Delegate to represent the Northeastern System Federation at the 30th International Teamsters Convention are as follows:

NESF Delegate
